

ation decreases to 7.0 percent

The annual rate of inflation, as measured by the all items Consumer Price Index (CPI), decreased by 0.3 percentage points, from 7.3 percent in December 2012 to 7.0 percent in January 2013. This means that on average, prices increased by 7.0 percent between January 2012 and January 2013. The decrease in annual inflation is attributed mainly to decreases in some food prices.

### Movements in Annual Inflation Rates for CPI Main Groups

Between January 2012 and January 2013, the annual rate of inflation increased for Alcoholic Beverages and Tobacco; Clothing and footwear; Transport; Education; Restaurant and hotel and Miscellaneous Goods and Services.

The annual rate of inflation decreased for Food and non-alcoholic beverages; Housing, water, electricity, gas, and other fuels; Furnishings, Household Equipment and Routine Household Maintenance, Health; Communication; and Recreation and culture.

#### The Month on Month Food and Non-food Inflation Rate

The month - on- month food inflation rate was recorded at 1.1 percent in January 2013 compared to 1.0 percent recorded in December 2012. This implies that the monthly food inflation rate increased by 0.1 percentage points.

Between December 2012 and January 2013, Non-food inflation rate decreased by 0.1 percentage points from 0.6 percent in December 2012 to 0.5 percent in January 2013.

#### Provincial Contribution to overall Inflation

Lusaka Province made the largest provincial contribution of 1.9 percentage points to the overall annual inflation rate of 7.0 percent recorded in January 2013. This was followed

by Copperbelt Province which contributed 1.7 percentage points. North-western had a lowest contribution of 0.1 percentage points.

### Changes in Inflation Rates for Provinces

Annual rate of inflation increased for Central, Lusaka, North-western, Southern and Western provinces, while it decreased for Copperbelt, Eastern, Luapula and Northern/Muchinga Provinces.

Southern Province had the highest annual rate of inflation at 9.9 percent. This was followed by Copperbelt Province at 7.6 percent while North-western Province had the lowest annual rate of inflation at 3.9 percent in January, 2013.

#### National Average Prices of Selected Products

A comparison of retail prices between December 2012 and January 2013 shows that the national average price of a 25 kg bag of breakfast Mealie meal increased by 1.6 percent from KR 56.67 to KR 57.56. The national average price of a 25 kg bag of roller mealie meal increased by 5.0 percent from KR 42.96 to KR45.09. The national average price

of a 20 litre tin of Maize grain increased by 9.0 percent from KR 22.38 to KR 24.39.

The average price of 2 liters of Cooking oil Local decreased by 1.7 percent from KR 35.46 to KR 34.86. The average price of one-way Air fare on Lusaka/London route decreased by 15.4 percent from KR 6,010 to KR 5,085.

012 records Trade Surplus

Zambia recorded a trade surplus valued at K 135.9 Billion (KR 135.9 Million) in December 2012 from K 112.8 Billion (KR 112.8 Million) recorded in November 2012. This means that the country exported more in December 2012 than it imported, in the same month, in nominal terms.

The country has continued to record trade surpluses since January 2012 with the highest valued at K473.2 Billion (KR 473.2 Million) recorded in August and the lowest trade surplus was recorded in February, valued at K47.4 Billion (KR 47.4 Million).

intermediate goods category (mainly comprising copper cathodes and sections of refined copper) accounting for 73.4 percent. Other exports were from the Consumer goods, Raw materials and Capital goods categories which

collectively accounted for 26.6 percent of total exports in December 2012. This implies that between December and November 2012, the country has been a net exporter of Intermediate goods, mainly Metals and their articles, accounting for an average of 73.7 percent of the total exports.

# Zambia's Metal Exports and Non-Traditional Exports (NTEs), December and November 2012

There has been a decrease in the total value of Metal exports from K2, 842.4 Billion( KR 2,842.4 Million) in November 2012 to K2, 653.6 Billion( KR 2,653.6 Million) in December 2012. The overall contribution of Metals and their products

to the total export earnings in December and November 2012 averaged 65.8 percent. The share of NTEs recorded an average of 34.2 percent in revenue earnings between December and November 2012.

accounted for 42.2 percent. The major export products were Cathodes & Sections of Cathodes of refined Copper accounting for 93.1 percent.

China was the second major destination of Zambia's exports accounting for 20.0 percent. The chief export product was copper blister (65.1 percent).

South Africa was the third major export destination accounting for 13.6 percent. The main export products were Brans, sharps and other residues of maize, accounting for 56.1 percent.

The fourth major export destination was Congo DR, accounting for 6.7 percent. The main export products were Pallets, box pallets and other load boards of wood; pallet collars of wood (17.5 percent).

The fifth major export destination was Malawi which accounted for 6.6 percent. The major export products were Candles, tapers and the like which accounted for 93.1 percent.

These five countries collectively accounted for 89.2 percent of Zambia's total export earnings in December 2012.

Southern African The Development Community (SADC) was the largest market for Zambia's total exports, accountina for 30.5 percent December 2012. Within SADC, South Africa was the dominant market with 44.7 percent. Other markets in SADC were Congo DR, Malawi, Zimbabwe and Tanzania.

Asia regional grouping was the second largest market for Zambia's total exports, accounting for 24.4 percent December 2012. Within Asia, China market. dominated the export accounting for 81.9 percent. notable markets in Asia were United Arab Emirates, India, Hong Kong Singapore.

The Common Market for Eastern and Southern Africa (COMESA) was the third largest market for Zambia's total exports accounting for 16.4 percent in December 2012. Within COMESA, Congo DR was the dominant market with 40.9 percent. Other markets in COMESA were Malawi, Zimbabwe, Mauritius and Burundi.

The European Union (EU) was the fourth largest market for Zambia's total exports accounting for 2.0 percent in December 2012. Within the EU, United Kingdom was the dominant market with 36.8 percent in December 2012. Other notable markets were Belgium, Netherlands, France and Slovenia.

Zambia's major import products by category in December 2012 were Capital goods, accounting for 34.6 percent. The Intermediate Goods category was second with 25.6 percent, followed by Consumer Goods with 22.1 percent. Raw

materials category was fourth with 17.8 percent. In December and November 2012, the country has been a net importer of Capital goods, contributing an average of 38.6 percent of the total imports.

The second main source of Zambia's imports was Congo (DR), which accounted for 21.9 percent. The major import products were Copper ores and concentrates, which accounted for 58.9 percent.

The third main source of Zambia's imports in December 2012 was Kuwait, accounting for 8.1 percent of the total value of imports. The major import products were Petroleum oils and oils obtained from bituminous minerals, crude including regulators accounting for 97.8 percent.
