
INFLATION

CONSUMER PRICE INDEX

YEAR ON YEAR INFLATION RATE FOR AUGUST 2018 INCREASES TO 8.1 PERCENT

The year on year inflation rate as measured by the all items Consumer Price Index (CPI) for August 2018 increased to 8.1 percent from 7.8 percent recorded in July 2018. This means that on average, prices of goods and services increased by 8.1 percent between August 2017 and August 2018. The increase in the annual rate of inflation is mainly attributed to both food and non-food items such as Breakfast Mealie meal, Cassava meal, purchase of Vehicles and Charcoal.

YEAR ON YEAR FOOD AND NON-FOOD INFLATION RATE

The year on year (Annual) food inflation rate for August 2018 was recorded at 8.3 percent compared to 8.1 percent recorded in July 2018 indicating an increase of 0.2 percentage points. The increase in the annual food inflation rate is mainly as a result of price changes of Breakfast Mealie meal and Cassava meal. The year on year (Annual) non-food inflation rate for August 2018 was recorded at 7.8 percent from 7.6 percent recorded in July 2018, indicating an increase of 0.2 percentage points. The increase is mainly attributed to price changes of Vehicles and Charcoal.

The annual inflation rate for August 2018 reduced for Alcoholic beverages and Tobacco; Clothing & Footwear and Health. The annual rate of inflation remained the same for Housing, water, electricity, gas and other fuels and Education.



PROVINCIAL CONTRIBUTION TO OVERALL INFLATION

Lusaka Province had the highest provincial contribution of 2.5 percentage points to the overall annual inflation rate of 8.1 percent recorded in August 2018. This implies that the price movements in Lusaka Province had the greatest influence on the overall annual rate of inflation. Copperbelt Province had the second highest provincial contribution of 1.4 percentage points while Luapula, North western and Western provinces had the lowest contribution of 0.3 percentage points each.

On a monthly basis, a comparison of retail prices between July 2018 to August 2018 shows that the national average price of a 25 kg bag of Breakfast Mealie meal increased by 1.24 percent from K78.42 to K79.39 while the national average price of a 25 kg bag of Roller Mealie meal increased by 0.96 percent from K56.44 to K56.98. The national average price of a 20 litre tin of Maize grain increased by 2.41 percent from K29.82 to K30.54. On an annual basis, a comparison of retail prices between August 2017 and August 2018 shows that the national average price of a 25kg bag of Breakfast Mealie meal increased by 2.74 percent from K77.27 to K79.39. The national average price of a 20 litre tin of Maize grain decreased by 1.71 percent from K31.07 to K30.54.

INTERNATIONAL MERCHANDISE TRADE

JULY 2018 RECORDS A TRADE DEFICIT

Zambia's trade deficit decreased by 48.8 percent from K1,620 million recorded in June 2018 to K829 million in July 2018. This trade deficit means that the country imported more than it exported in nominal terms. Imports decreased by 12.9 percent from K10,190.3 million in June 2018 to K8,877.4 million in July 2018, this decrease is mainly attributed to the decrease in the imports of Capital Goods by 20.1 percent from K3,345.7 million in June 2018

to K2,672.9 million in July 2018. Exports decreased by 6.1 percent from K8,570.3 million in June 2018 to K8,048.5 million in July 2018. The decrease in the value of Exports is mainly attributed to the drop in the Traditional Exports by 8.8 percent from K6,633.0 million in June 2018 to K6,049.9 million in July 2018. The reduction in the trade deficit is due to the decrease in imports outweighing that of exports.

PERFORMANCE OF EXPORTS (TRADITIONAL AND NON-TRADITIONAL EXPORTS (TES AND NTES)), JULY 2018 AND JUNE 2018

The Traditional Export earnings decreased by 8.8 percent from K6,633.0 Million in June 2018 to K6,049.9 Million in July 2018. The share of TEs recorded an average of 76.3 percent in revenue earnings between July 2018 and June 2018. Non-Traditional Exports (NTEs) increased by 3.2 percent from K1,937.2 Million in June 2018 to K1,998.6 Million in July 2018. The share of NTEs recorded an average of 23.7 percent in revenue earnings between July 2018 and June 2018.


ZAMBIA'S EXPORTS OF COPPER BY VOLUME AND CORRESPONDING LME PRICES. **JULY 2018 AND JUNE 2018**

The volume of Copper exported in July 2018 decreased by 1.8 percent from 92,052.4 metric tonnes in June 2018 to 90,410.4 metric tonnes in July 2018.

The Copper prices on LME market for the corresponding months decreased by 10.2 percent, from \$6,954.8 per metric tonne in June 2018 to \$6,248.2 per metric tonne in July 2018.

Since Copper accounts for the largest weight/ proportion of Traditional Exports, any change in the volume and price/value has a direct bearing on the performance of Traditional Exports.

PERFORMANCE OF NON-TRADITIONAL EXPORTS (NTES), JULY 2018 AND JUNE 2018

For the purpose of this analysis, Non-Traditional Exports are divided into Agricultural and Non-Agricultural products.

Agricultural Products

Agricultural products accounted for a share of 31.9 percent of Zambia's Non-Traditional Exports (NTEs) in July 2018 compared to 24.2 percent recorded in June 2018.

The export earnings from Agricultural products recorded a 35.8 percent increase from K469.4 Million in June 2018 to K637.6 Million in July 2018. The major export commodities were 'Cotton, not carded or combed' (20.0 percent), 'Tobacco not stemmed/stripped' (11.2 percent) and 'Oil-cake and other solid residues of soya bean' (11.0 percent).

Non-Agricultural Products

Non-Agricultural products accounted for a share of 68.1 percent of Zambia's Non-Traditional Exports (NTEs) in July 2018 compared to 75.8 percent recorded in June 2018.

The export earnings from Non-Agricultural products recorded a decrease of 7.3 percent from K1,467.8 Million in June 2018 to K1,361.0 Million in July 2018. The major export commodities were 'Sulphuric acid; oleum in bulk' (10.6 percent) and 'Cobalt oxides and hydroxides; commercial cobalt oxides in bulk' (8.8 percent).



EXPORTS BY MAJOR PRODUCT CATEGORIES, JULY 2018 AND JUNE 2018

Zambia's major export products in July 2018 were from the intermediate goods category (mainly comprising Copper anodes for electrolytic refining and Cathodes of refined copper) accounting for 84.1 percent. Exports from the Consumer goods, Raw Materials and Capital goods categories, collectively accounted for 15.9 percent of Total exports in July 2018.

ZAMBIA'S MAJOR EXPORT DESTINATIONS BY COMMODITY IN JULY 2018

The major export destination in July 2018 was Switzerland, which accounted for 36.1 percent of the total export earnings. The main export product to Switzerland was Copper anodes for electrolytic refining, accounting for 54.1 percent of total export earnings from that country, followed by Cathodes and sections of cathodes of refined copper (21.5 percent).

China was the second main destination of Zambia's exports accounting for 19.6 percent of the total export earnings. The main export product to China was Copper anodes for electrolytic refining, accounting for 49.1 percent of total export earnings from that Country.

Congo DR was the third main export destination accounting for 9.3 percent of the total export earnings. The main export product was Sulphuric acid; oleum in bulk accounting for 19.3 percent of total export earnings from that country.

United Kingdom was the fourth main export destination accounting for 7.8 percent of the total export earnings. The main export product was Copper anodes for electrolytic refining, accounting for 37.3 percent of total export earnings from that country.

The fifth main export destination was Singapore, which accounted for 7.5 percent of the total export earnings. The main export products were Electro-won copper cathodes (High Purity), accounting for 42.3 percent of total export earnings from that country.

These five countries collectively accounted for 80.3 percent of Zambia's total export earnings in July 2018.

EXPORT MARKET SHARES BY SELECTED REGIONAL GROUPINGS AND MAJOR TRADING PARTNERS, JULY 2018 AND JUNE 2018

Switzerland was the largest market for Zambia's total exports in July 2018, accounting for 36.1 percent.

Asia was the second largest market for Zambia's total exports, accounting for 34.5 percent in July 2018. Within this grouping, China was the dominant market with 56.9 percent. Other notable markets in this grouping were Singapore, United Arab Emirates, Hong Kong and India.

The DUAL-SADC & COMESA grouping was the third largest market for Zambia's total exports, accounting for 11.8 percent in July 2018. Within this grouping, Congo DR was the dominant export market, accounting for 78.9 percent. Other notable markets in this grouping were Zimbabwe, Malawi, Swaziland and Madagascar.

The European Union grouping was the fourth largest market for Zambia's total exports,

accounting for 8.2 percent in July 2018. Within this grouping, The United Kingdom was the dominant market with 95.6 percent. Other notable markets in this grouping were Italy, Germany, Netherlands and Luxembourg.

The SADC exclusive grouping was the fifth largest market for Zambia's total exports, accounting for 7.1 percent in July 2018. Within this grouping, South Africa was the dominant market with 84.0 percent. Other notable markets within this grouping were Tanzania, Botswana, Mozambique and Namibia.

The COMESA exclusive grouping was the sixth largest market for Zambia's total exports, accounting for 1.8 percent in July 2018. Within this grouping, Kenya was the dominant market with 74.9 percent. Other notable markets were Rwanda, Burundi, Uganda and Egypt.



ZAMBIA'S MAJOR IMPORT SOURCES BY PRODUCT IN JULY 2018

The major source of imports in July 2018 was Congo DR, accounting for 28.4 percent. The major import products were Cobalt oxides hvdroxides: and cobalt commercial oxides in bulk. accounting for 59.2 percent of the import bill from that country.

The second main source was South Africa. accounting for 24.4 percent. The major import product was Sulphur of all kinds (excl. sublimed, precipitated and colloidal sulphur), which accounted for 4.5 percent of the import bill from that country.

China was the third main source of Zambia's imports, accounting for 11.0 percent. The major import products were Photosensitive semiconductor devices; light-emitting diodes accounting for 12.0 percent of the import bill from that country.

Other sources of Zambia's imports were Kuwait and United Arab Emirates, which collectively accounted for 10.5 percent of Zambia's imports.

The Dual SADC & COMESA grouping was the largest source of Zambia's imports accounting for 31.1 percent in July 2018. Within this grouping, Congo DR was the major source of Zambia's imports accounting for 91.4 percent. Other notable markets were Mauritius, Zimbabwe, Malawi and Swaziland.

Asia was the second largest source of Zambia's imports, accounting for 29.5 percent in July 2018. Within this regional grouping, China was the main source of Zambia's imports accounting for 37.2 percent. Other notable markets were Kuwait, United Arab Emirates, India and Japan.

The SADC exclusive was the third largest source of Zambia's imports, accounting for 28.2 percent in July 2018. Within this grouping, South Africa was the dominant market with 86.4 percent. Other notable markets were Tanzania, Namibia, Mozambique and Botswana.

The European Union (EU) was the fourth largest source of Zambia's imports accounting for 7.0 percent. Within this grouping, The United Kingdom was the main source of Zambia's imports with 23.4 percent. Other notable markets were Germany, Sweden, Netherlands and France.

The COMESA exclusive grouping was the fifth largest source for Zambia's imports accounting for 0.7 percent in July 2018. Within this grouping, Kenya was the dominant market with 60.5 percent. Other notable markets were Uganda, Egypt, Sudan and Rwanda.
