Zambia records a population of 13,046,508 persons, 2010 Census Preliminary results reveal!

According to the preliminary results from the 2010 Census of Population and Housing, the population of Zambia has increased to 13, 046,508 persons from 9,885,771 persons in the


year 2000. Of the 13,046,508 persons, 6,394,455 (49 percent) were male while 6,652,053 (51 percent) were female.


Results also show that 7,978,274 persons (61 percent) were in rural areas while 5,068,234 (39 percent) persons were in urban areas.

At provincial level, Lusaka had the largest population with 2,198,996 persons, followed by Copperbelt with 1,958,623, Northern with 1,759,600, Eastern with 1,707,731 and Southern with 1,606,793 persons. The province with the least population was North-western with 706,462 persons. Western Province had 881,524 while Luapula had 958,976 persons.




Population Distribution by Province, Zambia 2010

Eligible Voters

The Census results further show that there were 6,069,753 total number of eligible voters (i.e. any person aged 18 years and above) in 2010 representing 47 percent of the total Zambian population. Results show that Lusaka Province had the highest share of eligible voters at 19 percent followed by

Copperbelt Province at 17 percent whereas Northern and Eastern provinces had 12 percent of eligible voters each. Southern province had a share of 11 percent; Central province had 10 percent while Luapula and Western provinces had 7 percent each. The province with the least share of eligible voters was North-western Province with 5 percent.




Percent share of eligible voters by Province, Zambia 2010

INFLATION

January Inflation rises to 9.0 percent

The annual rate of inflation, as measured by the all items Consumer Price Index (CPI), increased to 9.0 percent in January 2011, from 7.9 percent in December, 2010. The rise is attributed to increases in the cost of both food and non-food items.

Changes in annual inflation rates for CPI Main Groups

Between December 2010 and January 2011, annual inflation rates increased for Food, beverages and tobacco; Household fuel and lighting; Furniture and household goods; Medical care; Transport and communication; and Other goods and services. The annual inflation rates reduced for Clothing and footwear; and Recreation and education.

National Average Prices of Selected Products

A comparison of retail prices between December 2010 and January 2011, shows that the national average price of a 25 kg bag of white breakfast mealie meal reduced by 1.1 percent, from K53, 187 to K52,605 while the average price of the same bag of white roller mealie meal slightly increased by 0.1 percent, from K37,386 to K37,408. The national average price of a 20 liter tin of maize grain increased by 2.6 percent, from K21, 044 to K21, 601. The national average price of 1kg of dried bream (fish) increased by 12.8 percent, from K35, 275 to K39, 806. The national average price of 1kg of tomatoes increased by 10.8 percent, from K3, 597 to K3,984, while the average price of 1kg of cabbage(vegetable) increased by 30.6 percent, from K1,554 to K2,030. The national average price of a 1kg of dried beans also increased by 7.4 percent, from K9.976 to K10, 716.

INTERNATIONAL MERCHANDIZE TRADE

December 2010 records Trade Surplus

Zambia recorded a trade surplus valued at about K840.6 Billion in December 2010. This means that the country exported more in December 2010 than it imported in value terms. Since January 2010, the country has had monthly trade surpluses with the highest valued at about K1,147.7 Billion in March, 2010.


Total Exports (fob) and Imports (cif), January to December, 2010 (K' Millions)

Exports by Major Product Categories December and November, 2010

Zambia's major export products in December 2010 were from the Intermediate goods category (mainly comprising copper cathodes and sections of refined copper and copper blister) accounting for about 86.8 percent. Other exports were from the Consumer goods, Raw materials and Capital goods categories; which collectively accounted for about 13.2 percent of total exports for December 2010.

Zambia's Metal Exports and Non-Traditional Exports (NTEs) December and November, 2010

There has been a marginal increase in the total value of exports to K3,220.8 billion from about K2,971.8 billion between December and November 2010. This resulted in the country's ever dominant metal products recording a slight increase in revenue of about 4.9 percent in nominal terms. The overall contribution of metal products to the

total export earnings in December and November 2010 averaged about 84.8 percent in both months.

In terms of percentage contribution to the total export earnings, NTEs recorded an average of about 15.1 percent in both months.



Zambia's Major Export Destinations by Product in December, 2010

Zambia's major export destination in December 2010 was Switzerland accounting for 61.2 percent. The major export products to Switzerland were; Cathodes & Sections of Cathodes of refined copper; and Plates, sheets and strips of refined copper.

China was the second largest destination of Zambia's total exports accounting for 14.9 percent. The major export products to China were Copper blister; Cathodes & sections of cathodes of refined copper; and other articles of cobalt.

South Africa was the third largest export destination accounting for about 10.0 percent. The major export products to South Africa were Cathodes and sections of cathodes of refined copper; semimanufactured gold (incl. gold plated platinum); and Wire of refined copper, maximum cross-sectional dimension >6mm. The Democratic Republic of Congo was the fourth largest destination of Zambia's total exports accounting for 4.1 percent. The major export products to this nation were Raw cane sugar, in solid form; Portland cement (excl. white); Wheat or meslin flour; and Sulphuric acid.

Belgium was the fifth largest destination of Zambia's total exports accounting for 1.8 percent. The major export products were: Maize *(excluding seed)*; Ash and residues containing mainly copper and parts of air/vacuum pumps of air/gas compressors.

These five countries collectively accounted for 92.0 percent of Zambia's total export earnings in December 2010.

Export Market Shares by Regional Groupings, December and November, 2010

The Southern African Development Community (SADC) regional grouping was the largest market for Zambia's total exports, accounting for 17.4 and 18.3 percent in December and November 2010, respectively. Within SADC, South Africa was the dominant market in both months with 57.4 and 45.1 percent, respectively. Congo (DR) was second in both months with 23.4 and 27.1 percent, respectively. Other notable markets were Zimbabwe, Mauritius, Malawi and Tanzania.

Asia was the second largest market for Zambia's total exports, accounting for 15.9 and 19.4 percent in December and November 2010, respectively. Within Asia, China was the dominant market in both months with 93.3 and 91.9 percent, respectively. The United Arab Emirates was second in both months with 3.1 percent in December and 6.7 percent in November 2010, respectively. Other notable markets were India, Philippines, Israel and Hong Kong. The Common Market for Eastern and Southern Africa (COMESA) grouping of countries was the third largest market for Zambia's total exports accounting for 7.5 and 11.0 percent in December and November 2010, respectively. Within COMESA, Congo (DR) was the dominant market in both months with 54.4 percent in December and 45.1 percent in November 2010. Zimbabwe was second with 22.8 percent in December 2010 and 19.3 percent in November 2010. Other notable markets were Burundi, Malawi, Mauritius, Kenya and Egypt.

The European Union (EU) was the fourth largest market for Zambia's total exports accounting for 4.5 and 5.5 percent in December and November 2010, respectively. Within the EU, Belgium was the dominant market in December 2010 with 40.6 percent while the United Kingdom was the dominant market in November 2010 with 32.7 percent. Other notable markets were Luxembourg and the Netherlands.

Other notable imports were from the Raw materials and Consumer goods categories which collectively accounted for 40.4 percent in December 2010.

Zambia's Major Import Sources by Product, December 2010

The major source of Zambia's imports in December 2010 was South Africa accounting for 39.7 percent. The major import products from South Africa were Dumpers for offhighway use; Parts of machinery; Other medicaments of mixed or unmixed products; and Cutting oil, grease cutting oils, cleaning oils.

The second largest source of Zambia's imports in December 2010 was Congo DR accounting for 24.5 percent of the total value

of imports. The major import products from Congo DR were Copper ores and concentrates; Cobalt oxides and hydroxides, commercial cobalt oxides; and Cobalt ores and concentrates.

Other notable sources of Zambia's imports were China, India and the United Arab Emirates, collectively accounting for 11.3 percent of Zambia's total imports in December 2010

Import Market Shares by Regional Groupings, December and November, 2010

The Southern African Development Community (SADC) regional grouping was the largest source of Zambia's imports accounting for 68.4 and 69.2 percent in December and November 2010, respectively. Within the SADC region, South Africa was the major source of Zambia's imports in both months with 58.0 percent in December and 59.9 percent in November 2010. Congo DR was the second largest source of Zambia's imports with 35.7 and 34.3 percent in December and November 2010, respectively. Other key market sources were Zimbabwe, Tanzania, Swaziland and Botswana.

The Common Market for Eastern and Southern Africa (COMESA) grouping of countries was the second largest source of Zambia's imports accounting for 28.3 and 27.7 percent in December and November 2010, respectively. Within COMESA, Congo (DR) was the main source of Zambia's imports in both months with 86.3 and 85.8 percent, respectively. Other notable sources were Zimbabwe, Kenya, Swaziland, Mauritius and Egypt.

Asia was the third largest source of Zambia's imports accounting for 18.2 and 15.6 percent in December and November 2010,

respectively. Within Asia, China was the dominant market with 32.8 and 34.0 percent in December and November 2010, respectively. Other notable markets were India, United Arab Emirates, Kuwait, Japan and Singapore.

The European Union (EU) was the fourth largest source of Zambia's imports

accounting for 8.6 and 10.5 percent in December and November 2010, respectively. Within the EU, the United Kingdom was the major source of Zambia's imports accounting for 25.5 and 21.8 percent in December and November 2010, respectively. Other key markets were Finland, Ireland, Sweden, Germany and the Netherlands.
